The European Union does not recognise and will not recognise the authorities resulting from the putsch in Niger. President Bazoum was democratically elected; he is and remains the only legitimate President of Niger. His release must take place unconditionally and without delay. The EU holds the putschists accountable for his safety and that of his family.

The announcement by the putschists of the suspension of the constitution and the dissolution of democratic institutions weakens the State and the people of Niger whose peace, stability and security must be preserved.

The European Union reiterates its very clear calls for the full restoration, without delay, of the constitutional order and fully associates itself with the declarations of ECOWAS and its African and international partners in this regard. In
